



# SUSTAINABLE PURCHASING GUIDE

Goods and services we procure can have a huge impact on the environment and the natural resources. We can reduce our environmental impact and carbon footprint by changing our purchasing practices and taking more informed purchasing decisions. Purchasing is a good way of communicating our preference for environmentally friendly products to suppliers, manufacturers and the wider community. The <a href="Environmental Policy">Environmental Policy</a> endorsed by the Bloomsbury Colleges commits Birkbeck to "adopt sustainable purchasing and the use of environmentally sound goods and services".

The information on the following pages contain sustainability criteria and associated verification mark or 'proof' to look out for when making some common purchases.

## Stationery and office supplies reuse

## Paper

#### Sustainability Criteria

Below are the key environmental criteria to consider for paper:

- The paper must be at least Elementary Chlorine Free (ECF). Totally Chlorine Free (TCF) will also be desirable
- Use paper that is not only 100% recycled but have a very low environmental impact the 'Steinbeis Classic paper' meets this requirement and is the recommended paper for general use. This paper uses over 80% less water, 50% less energy and does not use any chemicals or bleach.

#### Verification

Appropriate proof from the supplier or ask for the <u>EU Ecolabel</u> or <u>paper-by-nature</u> Ecolabel



#### **Sustainability Criteria**

Firstly please check with the estates team if there is any spare furniture that you can use before buying anything new. For any surplus furniture please contact the <u>Sustainability Team</u> to help you arrange a charity collection. If you do have to buy new furniture purchase items produced through environmentally friendly processes and materials. See environmental criteria for furniture below:

Sustainability Criteria		Verification
Wood or wood based materials – should come from legally sourced timber.	FSC	Check for <u>FSC</u> , <u>PEFC</u> certification or equivalent means of proof, including technical dossier or test report from an independent body. Also check for furniture made from reclaimed materials
Plastic parts – should be marked for recycling and not contain other materials that may hinder their recycling	Ecolabel www.ecolabel.eu	Products carrying a 'type I Ecolabel' would fulfil this category. Other appropriate means of proof like technical dossier or test report from an independent body. (Type I Ecolabels are multi criteria based, third party certified environmental labeling programme – e.g. EU Ecolabel & EPEAT).
Surface-coating of wood, plastic or metal part of the furniture – should not contain hazardous substances	Ecolabel www.ecolabel.eu	Furniture carrying a 'type I Ecolabel' will be deemed to comply. Other appropriate means of proof like technical dossier or test report from an independent body.

### **Laboratory Equipment**



#### Sustainability Criteria

The first steps to reducing environmental impact in Labs is through sustainable purchasing

- Use approved suppliers for lab equipment and always choose energy efficient options,
- Consider whole life costing and end of life disposal,
- Fume cupboards should be low-flow VAV, unless otherwise justified,
- Consider buying products that have water conservation features,
- Follow existing guidance on 'freezer' procurement and refer to the 'Freezer Policy' guidance for more information

### **ICT Equipment**



#### **Sustainability Criteria**

This guidance applies to all ICT equipment (computing, telephony, printing and smartphones). It is advisable for staff to contact the IT and/or procurement for their ICT equipment needs.
